<b>Processes</b>	<p><b>Step 1</b> is for a prospective applicants to establish what their chosen NPQ involves and whether it is suitable for them.</p>	<p><b>Step 2</b> is for applicants to register with the DfE and choose UCL IOE as their Lead Provider. The DfE platform will check the applicant's TRN and, through their school postcode, their eligibility for a scholarship. The DfE will then pass on the applicant's details to UCL IOE.</p>	<p><b>Step 3</b> is for the data of registered applicants to be sent to UCL IOE. This data will include information about eligibility for scholarships. UCL IOE will then send the applicant a link to the UCL application form.</p>	<p><b>Step 4</b> is for UCL IOE to transfer participant information to Teach West London. Teach West London will then communicate directly with participants in preparation for programmes starting in November 2021.</p>
