We encourage the school DSL following introductory level training, to undertake training in line with HSCP priorities above. We do not provide a specific DSL course.

#### Safeguarding Children Leads update online MS Teams

#### For leads in schools + early years + health and social care staff

This update focusses on the proper management of potential harm that can be caused to children by professionals working in our varied settings and the management of allegations sometimes made by children young people and parents. Hounslow's LADO service and the national Disclosure and Barring Service (DBS) can be key to this area of safeguarding work.

The Disclosure and Barring Service (DBS) was formed in 2012 to help employers make safer recruitment decisions. DBS Regional Outreach Service focuses on working collaboratively with safeguarding and recruiting organisations to offer localised DBS support and developing understanding. Kiran Rehal is the DBS Regional Outreach Adviser for Greater London and will be delivering this lunchtime online session with Hounslow's LADOs Grace Murphy and Sarah Paltenghi.

During this one hour online session they will explain their respective roles and will include:-

- Different levels of DBS checks
- When an employee is eligible for a check
- DBS Update Service
- Barring and Duty to Refer
- Making a good barring referral

### Two day course. Youth Mental Health First Aid

In person. St John's Road. Isleworth. 7+8/11/22 16+17/1/23 24+25/4/23 9.00-4.30 26+27/6/23

There is concern at increasing mental health problems among children and young people and particularly since Covid. Non-mental health specialists are increasingly encountering young people in need of basic mental health support. This course aims to equip the non-specialist with the knowledge and skill to provide Mental Health First Aid to young people ensuring those who need it can access appropriate help quickly. After completing the two day course you will receive a certificate saying that you are a Youth Mental Health First Aider.

### Domestic Abuse and Violence, an Introduction. Basic Professional Awareness and Understanding.

Domestic abuse and violence is a fact of life for a high proportion of children living in families where there are safeguarding or child protection concerns (45-90% of families). Abusive and violent behaviour in intimate relationships is a complex and puzzling phenomenon both from the perpetrators and survivor point of view. There are many myths and huge stigma that can get in the way of professionals being able to effectively help women; mothers to make decisions that are in their own and their children's best interests.

This course offers professionals the opportunity to explore reflect and gain insight and understanding to be able to better connect with and help women who find themselves in violent and abusive relationships.

### Forced marriage and 'Honour' based violence

In a borough with Hounslow's diversity we would expect services to be called on to safeguard children and young people from illegal and harmful cultural practices such as forced marriage and associated 'honour' related violence. However, this rarely features in the work of our protective services. These are hidden problems and there is work to do to raise awareness and the capacity of professionals and community organisations to offer help and support to affected people in our community. This course is part of that initiative led by the community safety partnership within Hounslow's VAWG strategy (Violence against Women and Girls).

### Criminal and sexual exploitation. Safeguarding young people.

In recent years several high profile prosecutions and enquiries such as Oxford and Rotherham exposed a lack of professional understanding about these forms of child abuse. As a result we saw that the children and young people targeted by abusive adults were often left unprotected by professionals. Often the abuse of the children escalated a result of the professional failure.

Understanding has grown as a result of these cases and we are more aware of how such abuse is organised and perpetuated and various systems are in place to co-ordinate better detection of offenders and improved protection of children and young people. There have also been developments in improved ways of working with and communicating with young people. This is important because many children who are entrapped into sexual or criminal exploitation have said nobody had ever told them how to recognise risky people or situations.

### **Familial Child Sexual Abuse**

#### Aims

Hounslow Safeguarding Children Partnership has made familial child sexual abuse a priority and is developing a strategy to improve our work in this important area of child protection. In the UK we 'miss' most children who are sexually abused. According to the Office of the Children's Commissioner we identify only 1 in 8 children at risk. We asked Hounslow professionals what they need to help them to keep children safe. They told us they need training as a starting point. This course aims to equip professionals across the children's workforce with basic knowledge about familial sexual abuse and enhance confidence in our existing communication skills with children and young people.

#### Aims

Hounslow SCP made familial child sexual abuse a priority in 2021 and is responding to professional requests for training by providing this and related courses on neighbouring pages in this brochure. This course is particularly important because about 40% of children who are abused sexually in their family are abused by a sibling or other close relative such as cousin nephew, niece. Harmful sexual behaviour by young people particularly in the family is challenging to our conception of what sibling relationships are like and can be complex and an emotional concern to deal with. This course aims to equip professionals with increased awareness and understanding of the nature of harmful sexual behaviour in children and young people, improve assessment and intervention and enable better support to the children and young people involved and their parents/carers.

#### Aims

Hounslow Safeguarding Children Partnership members have agreed that familial child sexual must be a priority and a strategy to improve our work here is in development. Nationally we 'miss' most children who are sexually abused, the Office of the Children's Commissioner estimate we identify only 1 in 8 children at risk. We undertook an audit of our own practice in 2020 and found most cases required improvement and some were not adequate. This is nobody's fault. Familial sexual abuse is probably the most challenging area of child protection work and over the past 20 years there has been a steady decline in the number of children coming to notice. This means many professionals including managers have not had the opportunity to deal with the complexities and learn. The result is that almost none of us are properly equipped to manage this work. For this reason we are committed to developing our staff and enabling the workforce to better understand and respond to concerns about sexual abuse in the family environment.

**Hounslow Safeguarding Children Partnership made familial sexual abuse a priority** following an audit in 2020 and after professionals told us they feel unprepared for this area of child protection.

The knowledge and skill gap is of course not just local, it is a national concern. The centre of expertise was funded by the Home Office to better tackle child sexual abuse by understanding its causes, scope, scale and impact. We know a lot about child sexual abuse and some progress has been made in dealing with it, but gaps in knowledge and understanding limit how effectively we are tackling the issue.

The centre has developed a Signs and Indicators Template to aid professional understanding. Hounslow Safeguarding Children Partnership has arranged this online event with the centre to showcase the resource and disseminate this in Hounslow. Click for quick information about the template:

Brook Traffic Light Tool training. Delivered via Zoom by Brook for Hounslow

Brook's nationally recognised Sexual Behaviours Traffic Light Tool training provides a highly visible, multi-agency response that helps professionals to identify, understand and respond appropriately to sexual behaviours in young people.

The tool and accompanying training provide professionals within and across organisations with a framework for identifying whether behaviour is part of healthy development or if there is cause for concern. It will also provide guidance on when to safeguard and/or signpost to internal or external support.

The training equips professionals to make consistent and informed decisions that neither pathologies nor criminalises young people. Participants will be trained to have robust and meaningful conversations around harmful sexual behaviour that causes concern and will be equipped to embed the tool within their practice.

#### Learning outcomes: by the end of the training participants will be able to

- Explain parts of the law which refer to sexual behaviour
- Know how their values relating to sexuality affect decision making
- Rate different scenarios as green, amber or red
- Use an action plan; created in the training, to support the integration of the toolkit into internal training

### Sex Pressures and Pornography Course delivered via Zoom by Brook for Hounslow



Brook is a UK based charity offering a wide variety of sexual health services to young people mainly under 25. They are experts in this field.

#### Sex Pressures and Pornography

There is growing concern about the influence that freely available online pornography may have on the development of children and young people and on their relationships. The aim of these learning sessions with Brook is to enable participants to gain knowledge and skills about the influences and pressures young people face as they develop and explore their emerging sexuality.

The sessions aim to:-

- Offer an insight into the pressures of online life for young people
- Give an overview of the laws relevant to young people's sexual relationships, pornography and Youth Produced Sexual Imagery (YPSI)
- Consider the impact of pornography, YPSI and Image Based Sexual Abuse (IBSA) on young people and explore how to talk to young people about their relationships, pornography and YPSI

Sessions are open to any Hounslow professionals working with children and young people.

### Gender identity and sexual orientation

### The aim of this session delivered by Brook for Hounslow staff is to explore sexuality and gender and provide participants with more in-depth knowledge and skills around the topic.

Research shows that people are happier and more productive in an environment in which they feel they can be themselves without fear of harassment or abuse. Society as a whole is becoming more tolerant of the diversity of sexual orientations, but homophobia is still ingrained in many institutions and communities. This continues to have an extremely negative effect on the lives of LGBT+ people and should be considered in any gender and sexuality education programme.

#### Participants will be able to:

- Discuss attitudes to lesbian, gay, bisexual and transgendered young people
- Discuss stereotypes, judgements and assumptions around sexuality
- Describe LGBT + issues affecting young people and identify ways of supporting the young people you work with around these issues
- Gain knowledge and skills about the influences and pressures young people face as they develop and explore their emerging sexuality
- Increase empathy and understanding of LGBT + experiences
- Engage with and deliver education to young people in an LGBT + inclusive way
- Explore practical ways of challenging homophobic, bi phobic, transphobic bullying.
